

# Aura LED Truck Bed Strip Installation Guide

PLEASE READ THE FOLLOWING INSTRUCTIONS THOROUGHLY BEFORE INSTALLING AND OPERATING THE AURA TRUCK BED LED KIT

The following instructions are intended for universal applications and may not apply to your vehicle.

#### Truck Bed Kit Includes:

- Three (3) LED Strips with 1ft extensions on each end
- One (1) Aura Control Box
- One (1) OE-Rocker Switch with battery terminal rings
- One (1) Tailgate Pin Switch
- One (1) Car Cig Adapter
- One (1) Set of Acc wiring

#### Tools needed:

- Flathead screwdriver
- Hex screwdriver set
- Power Drill

# **Section 1: Preparation**

- A. Park, turn off the vehicle, and ensure the emergency brake is on
- B. Clean the mounting area with soap and water. Any excess dirt may reduce hold strength
- C. Wipe down the area with the included 3M Adhesive Booster to maximize your hold

# Section 2: Installing the Strips

- A. Arrange the light strips in your truck bed the way you would like them positioned.
- B. Remove the red 3M tape backing and press the strips up into the underside of the truck side panel.
- C. Press and hold firmly for 10 seconds. Repeat for each light.
- D. Connect all strip ends and cover the connectors with the included heat wrap tubes
- E. Connect the 8ft extension cord to each strip to the truck cab on each side.
- F. Feed the extension cords down any open hole on the side of the truck bed. If no hole exists, you will need to drill one.
- G. From under the truck, feed the cords towards the driver's side cab.
- H. Place the Aura Control box inside the cab and feed the control box cords to the underside. You may need to remove some interior paneling.
- I. Connect the control box cords to the light strip cords.
- J. Use the included zip ties to secure any loose wiring.

# **Section 3: Powering the Kit**

The Aura truck bed strip kit can be powered via 2 different methods

- A. Simple Method: Car Charger
  - a. Connect the car charger adapter to the Aura control box
  - b. Plug directly to your vehicle's 12v DC outlet and push "ON"

# B. Complete Method: OE-Style Switch

- a. Connect the OE-Style Switch to the Aura control box
- b. The Aura Control box has 2 sets of positive and negative wiring.
  - i. Use the wiring with ring terminals and connect directly to your car battery
  - ii. Please see Section 5B to wire the other set. Remove extra wiring if desired
- c. Connect the RED Pos ring to the positive terminal and the black Neg ring to the negative terminal
- d. To install the switch, your vehicle will need an open switch slot on the dashboard. This is

- usually found by removing a plastic panel covering the slot. Please check your owner manual for placement.
- e. Use the included zip ties to wrap up any loose wiring

# **Section 4: Activating your Kit**

- A. Switch "ON" with the OE-Style Rocker Switch
- B. Use the Wireless Remote to select desired feature
  - a. 16 different colors
  - b. 4 Fading Light Shows
  - c. 8 Brightness levels
  - d. SoundSync<sup>TM</sup>: Sound sensitive music feature that moves to the beat of ambient music

# Section 5: Enhanced functionality (optional)

The Aura Truck bed kit comes with 2 additional sets of wiring for custom solutions

- A. Automatic "On" when opening tailgate
  - a. Drill a small 3/10" hole in wall of your tailgate bracket (see image for detail)
  - b. Insert the included pin switch into tailgate bracket and adjust for proper fit and function
  - c. Feed the wiring line through the underbody back to the control box and connect
  - d. Use the included zip ties to wrap up any loose wiring
  - e. NOTE: This feature will bypass all other switches and will activate "white" light only The remote will not function when this is in use
- B. AUX wiring for connecting to your dome light or cargo light
  - a. An extra set of Pos and Neg wiring is provided to connect to a dome or cargo AUX light
  - b. NOTE: This feature will bypass all other switches and let you use any color

# AURA LED TRUCK BED Strip KIT Warranty

#### TWO YEAR NON-TRANSFERRABLE LIMITED WARRANTY AND DISCLAIMER

OPT7 Lighting, LLC ("OPT7 Lighting") warrants to the original retail consumer purchaser, and not any other purchaser or subsequent owner, that this Product will be free from defects in material or workmanship for a period of two (2) years from the purchase date. This warranty does not cover any Product that is (1) installed incorrectly, or (2) damaged by collisions, vandalism, other accidents, or similar causes.

For a period of two (2) years from the date of purchase, at no charge to the Purchaser, OPT7 Lighting will repair or replace this Product if it is determined by OPT7 Lighting to be defective. After the warranty period, the Purchaser must pay all charges for parts and labor.

Coverage under this warranty is only valid within the United States, including its territories, as well as in certain other countries. Purchasers should check our website, to determine the warranty coverage in the countries in which they are located.

OPT7 Lighting does <u>not warrant the installation</u> of the Product, which is the sole responsibility of the Purchaser. Installation should be done by licensed professionals. Improper installation may cause damage to the Product and any vehicle in which it is installed, and may cause burns and electrical injury to individuals. OPT7 Lighting's warranty does not cover any expenses incurred in removing Products that are defective or reinstalling replacement Products in their place.

During the warranty period, to have the Product repaired or replaced, the Purchaser must return the Product, freight prepaid by the Purchaser, to OPT7 Lighting (but for customers in the contiguous United States, OPT7 Lighting will pay the shipping charges if any Product fails during the first thirty (30) days affer purchase). The Product must be returned in its original carton or in a similar package affording an equal degree of protection. OPT7 Lighting will return the repaired or replaced Product, freight prepaid, to the Purchaser. OPT7 Lighting does not provide Purchasers with temporary replacement units during the warranty period or at any other time.

This limited warranty is non-transferrable and will automatically terminate if the original retail consumer purchaser resells the Product or transfers the vehicle on which the Product is installed. An "original retail consumer purchaser" is a person who originally purchases the Product, or a gift recipient of a new Product that is in its original packaging and unopened.

This limited warranty is subject to all of the following terms and conditions:

#### TERMS AND CONDITIONS

- 1. NOTIFICATION OF CLAIMS; WARRANTY SERVICE: IF PURCHASER BELIEVES THAT A PRODUCT IS DEFECTIVE IN MATERIAL OR WORKMANSHIP, WRITTEN NOTICE WITH AN EXPLANATION OF THE CLAIM SHALL BE GIVEN PROMPTLY BY PURCHASER TO OPT7 LIGHTING. ALL WARRANTY CLAIMS MUST BE MADE WITHIN THE WARRANTY PERIOD, AND ANY PRODUCTS RETURNED TO OPT7 LIGHTING MUST BE SHIPPED IN ACCORDANCE WITH OPT7 LIGHTING'S PROCEDURES (INCLUDING USE OF RMA NUMBERS SUPPLIED BY OPT7 LIGHTING AFTER NOTIFICATION). THE REPAIR OR REPLACEMENT OF ANY PRODUCT OR PART THEREOF SHALL NOT EXTEND THE ORIGINAL WARRANTY PERIOD. THE SPECIFIC WARRANTY ON THE REPAIRED PART ONLY SHALL BE IN EFFECT FOR A PERIOD OF NINETY (90) DAYS FOLLOWING THE REPAIR OR REPLACEMENT OF THAT PART, OR THE REMAINING PERIOD OF THE PRODUCT WARRANTY, WHICHEVER IS GREATER.
- 2. EXCLUSIVE REMEDY: ACCEPTANCE: PURCHASER'S EXCLUSIVE REMEDY AND OPT7 LIGHTING'S SOLE OBLIGATION IS TO SUPPLY (OR PAY FOR) ALL LABOR NECESSARY TO REPAIR ANY PRODUCT FOUND TO BE DEFECTIVE WITHIN THE WARRANTY PERIOD AND TO SUPPLY NEW OR REBUILT REPLACEMENTS FOR DEFECTIVE PARTS. OPT7 LIGHTING WILL REFUND THE PURCHASE PRICE FOR SUCH PRODUCT ONLY IF REPAIR OR REPLACEMENT FAILS TO REMEDY THE DEFECT. PURCHASER'S FAILURE TO MAKE A CLAIM AS PROVIDED IN PARAGRAPH 1 ABOVE OR CONTINUED USE OF THE PRODUCT SHALL CONSTITUTE AN UNQUALIFIED ACCEPTANCE OF SUCH PRODUCT AND A WAIVER BY PURCHASER OF ALL CLAIMS THERETO.

OPT7 LIGHTING EXCLUDES FROM WARRANTY COVERAGE PRODUCT'S SOLD AS IS AND/OR WITH ALL FAULTS. OPT7 LIGHTING ALSO EXCLUDES FROM WARRANTY COVERAGE ANY CONSUMABLE ITEMS SUCH AS FUSES AND BATTERIES.

All software and accompanying documentation furnished with, or as part of the Product is furnished "AS IS" (i.e., without any warranty of any kind), except where expressly provided otherwise in any documentation or license agreement furnished with the Product.

4. PROOF OF PURCHASE; REGISTRATION: The Purchaser's dated bill of sale must be retained as evidence of the date of purchase and to establish warranty eligibility. Registration of any Product or of this limited warranty is voluntary, and failure to register will not diminish any rights available under this warranty.

EXCEPT FOR THE FOREGOING WARRANTIES, OPT7 LIGHTING HEREBY DISCLAIMS AND EXCLUDES ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO ANY IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR ANY WARRANTY WITH REGARD TO ANY CLAIM OF INFRINGEMENT THAT MAY BE PROVIDED IN SECTION 2-312(3) OF THE UNIFORM COMMERCIAL CODE OR IN ANY OTHER STATE STATUTE.
